

Privacy notice for Parents/Carers - use of your child's personal data

Under data protection law, individuals have a right to be informed about how the University of Kent Academies Trust (UKAT) uses any personal data that we hold about them. We comply with this right by providing 'Privacy Notices' (sometimes called 'Fair Processing Notices') to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about students.

The University of Kent Academies Trust (UKAT) are the 'data controller' for the purposes of data protection law.

Our data protection officer is Julia Culham (see 'Contact us' below).

The personal data we hold

Personal data that we may collect, use, store and share (when appropriate) about students includes, but is not restricted to:

- · Contact details, contact preferences, date of birth, identification documents
- · Results of internal assessments and externally set tests
- · Student and curricular records
- Characteristics, such as ethnic background, eligibility for free school meals, or special educational needs
- · Exclusion information
- Details of any medical conditions, including physical and mental health
- · Attendance information
- Safeguarding information
- Details of any support received, including care packages, plans and support providers
- · Photographs
- · CCTV images captured on the Academy site

We may also hold data about students that we have received from other organisations, including other schools, local authorities and the Department for Education.

Why we use this data

We use this data to:

- · Support student learning
- Monitor and report on progress
- Provide appropriate pastoral care
- · Protect student welfare
- · Assess the quality of our services
- · Administer admissions waiting lists

· Comply with the law regarding data sharing

Our legal basis for using this data

We only collect and use students' personal data when the law allows us to. Most commonly, we process it where:

- · We need to comply with a legal obligation
- · We need it to perform an official task in the public interest

Less commonly, we may also process students' personal data in situations where:

- · We have obtained consent to use it in a certain way
- We need to protect the individual's vital interests (or someone else's interests)

Where we have obtained consent to use students' personal data, this consent can be withdrawn at any time. We will make this clear when we ask for consent and explain how consent can be withdrawn.

Some of the reasons listed above for collecting and using students' personal data overlap, and there may be several grounds which justify our use of this data.

Collecting this information

While the majority of information we collect about students is mandatory, there is some information that can be provided voluntarily.

Whenever we seek to collect information from you or your child, we make it clear whether providing it is mandatory or optional. If it is mandatory, we will explain the possible consequences of not complying.

How we store this data

We keep personal information about students while they are attending our Academies. We may also keep it beyond their attendance at our Academies if this is necessary in order to comply with our legal obligations. Our Records Management Policy sets out how long we keep information about students and is available on request from the Data Protection Officer.

Data sharing

We do not share information about students with any third party without consent unless the law and our policies allow us to do so.

Where it is legally required, or necessary (and it complies with data protection law) we may share personal information about students with:

- Medway Local Authority to meet our legal obligations to share certain information with it, such as safeguarding concerns and exclusions
- The Department for Education
- · The Student's family and representatives
- · Educators and Examining bodies
- Ofsted
- Suppliers and service providers to enable them to provide the service we have contracted them for
- Financial organisations such as the Educational School Funding Agency
- University of Kent our sponsors
- · Health authorities

National Student Database

We are required to provide information about students to the Department for Education as part of statutory data collections such as the school census.

Some of this information is then stored in the <u>National Student Database</u> (NPD), which is owned and managed by the Department and provides evidence on school performance to inform research.

The database is held electronically so it can easily be turned into statistics. The information is securely collected from a range of sources including schools, local authorities and exam boards.

The Department for Education may share information from the NPD with other organisations which promote children's education or wellbeing in England. Such organisations must agree to strict terms and conditions about how they will use the data.

Youth support services

Once our students reach the age of 13, we are legally required to pass on certain information about them to Medway Youth Trust, as it has legal responsibilities regarding the education or training of 13-19 year-olds.

This information enables it to provide youth support services, post-16 education and training services, and careers advisers.

Parents/carers, or students once aged 16 or over, can contact our data protection officer to request that we only pass the individual's name, address and date of birth to Medway Youth Trust

Transferring data internationally

Where we transfer personal data to a country or territory outside the European Economic Area, we will do so in accordance with data protection law.

Parents and Students' rights regarding personal data

Individuals have a right to make a 'subject access request' to gain access to personal information that UKAT holds about them.

Parents/carers can make a request with respect to their child's data where the child is not considered mature enough to understand their rights over their own data (usually under the age of 12), or where the child has provided consent.

Parents also have the right to make a subject access request with respect to any personal data that UKAT holds about them.

If you make a subject access request, and if we do hold information about you or your child, we will:

- · Give you a description of it
- Tell you why we are holding and processing it, and how long we will keep it for

- Explain where we got it from, if not from you or your child
- Tell you who it has been, or will be, shared with
- Let you know whether any automated decision-making is being applied to the data, and any consequences of this
- Give you a copy of the information in an intelligible form

Individuals also have the right for their personal information to be transmitted electronically to another organisation in certain circumstances.

If you would like to make a request, please contact our Data Protection Officer.

Your right to access your child's education record

Parents/carers may also request access to their child's educational record. The right applies as long as the pupil is aged under 18.

There are certain circumstances in which this right can be denied, such as releasing the information might cause serious harm to the physical r mental health of the pupil or another individual, or if it would mean releasing exam marks before they are officially announced.

To request access, please contact the Data Protection Officer.

Your other rights regarding your child's data

Under UK data protection law, you have certain rights regarding how your child's personal data is used and kept safe. For example, you have the right to:

- Prevent your child's data being used to send direct marketing
- Object to and challenge the use of your child's personal data for decisions being taken by automated means (by computer or machine, rather than by a person)
- In certain circumstances, have inaccurate personal data corrected
- In certain circumstances, have the personal data we hold about your child deleted or destroyed, or restrict its processing
- Withdraw your consent, where you previously provided it for the collection, processing and transfer of your child's personal data for a specific purpose
- In certain circumstances, be notified of a data breach
- Make a complaint to the Information Commissioner's Office
- Claim compensation for damages caused by a breach of the data protection regulations

To exercise any of these rights, please contact us (see 'Contact us" below).

Once your child is able to understand their rights over their own data (generally considered to be age 12, but this has to be considered on a case-by-case basis), we will need to obtain consent from your child for you to make a subject access request on their behalf.

Other rights

Complaints

We take any complaints about our collection and use of personal information very seriously.
